1. New article, which was **not published earlier**.

2. If the article is written in English, it is necessary to ensure **high quality of the English language**.

3. Maximum quantity of coauthors - 8 persons.
4. Standard volume of the article – from 4,000 to
6,000 words (from 13 to 20 pages, font 14, line-to-line spacing 1.5). Quantity of words (word count) is shown in the lower left-hand corner of the Microsoft Word window.

5. Name (topic) of the article – up to 10 words.

Headings. It is necessary to separate text of the article into proper parts and write down relevant headings: Abstract. Keywords. 1. Introduction. 2. Methods. 3. Literature Review. 4. Results. 5. Discussions. 6. Conclusions. References. Abstract (not less than 20 lines).

Keywords (not less than 12 words).

#### Introduction

(actuality of the article).

Introduction must be devoted to description of the problem, which is not solved yet by researchers or which is analyzed in the science only partially. It is necessary to state practical importance of this problem.

In addition, it is necessary to describe contribution of the present article to the global science.

You must find proper and correct formulations; there is no sense to write down any simple text, as many researchers usually do.

Volume – 1-2 pages.

Description of methods and procedures of investigations. You have to describe organization experiment, of the methods and devices, which were used, as well detailed present information concerning object the of investigations (alive objects (test persons) or unalive objects). Kinds of investigation the methods (the most commonly used): observation, polling testing, survey, experiment, laboratory test, analysis, simulation, study, and generalization. Volume – 1-2 pages.

**Literature review** in respect of the relevant topic. As concerns the literature review, it is very advisable to analyze from 20 to 40 literature sources and compare opinions of relevant authors; certain part of the literature sources must be written in English. Volume -1-2 pages.

#### **Results of investigations.**

Purpose and objectives of investigations.

Description of investigations. It is necessary to lay emphasis on your own thoughts and do not describe ideas and thoughts of other persons.

You must present at least some kind of the scientific novelty (or several paragraphs must be must seem interesting for further development of the world science).

Detailed description of the article topic is necessary.

Specific features of the article topic are necessary.

Advanced domestic experience.

Foreign experience.

Description of the certain kinds of the foreign experience, which can be used in your own country.

Which domestic experience is important for the world science? What kinds of the domestic and foreign experience are used already? What kinds of the domestic and foreign experience can be proposed for utilization in future?

Your thoughts in respect of future utilization of those points that are described in the article topic in your country and in the world. Volume -8-15 pages.

**Discussion of the obtained results**. This section includes generalization and assessment of results of your investigations. It is necessary to compare the results, which are described in your article, with results of the investigations, which were performed by other authors. Having analyzed other scientific concepts, you must state the concept, which can be used for explanation of the obtained results. Therefore, we will obtain an assessment of validity of the obtained results, as well as comparison of the obtained results with the existing results of other researchers. Author appoints specific position of the results, which were obtained in the course of these investigations, within the structure of the knowledge that is known to the mankind. Volume – 1-4 pages.

**Conclusions**. We summarize outcomes of the article in this section. Conclusions must be presented as the brief description of the main part of the article. Volume -1-2 pages.

**References**. It is very advisable to include from 30 to 40 literature sources to this section. Not less than 20 literature sources must be published during previous 3 years. It is necessary to include foreign literature sources in the quantity of not less than 15 publications.

**Formating**. There are no any general requirements to the formating of the article. They are not the same in various magazines. It is necessary to make formating for the specific magazine, which was selected for publication.

### Other specific features.

If your article is not a philosophical article, it must include not less than 1 table, as well as not less than 1 figure. These tables and figures must not be simple pictures of bad quality.

If your article describes results of the performed investigation, then Conclusions must include recommendations, as well as prospects of further investigations, which are planned by the author in future.

Grant. Grant must be described in the very beginning of the article. You have to state the following: grant number, issuer of the grant, and recipient of the grant.

Economics, technology, and other similar sciences. Such articles must include formulas, digits, calculations, statistical data, analytics, etc.

Medicine. Ethics of investigations of men and animals. The article must include information on the body, which has issued permit for such investigation. If there are no any permits, it is necessary to explain the reasons, in accordance with which such investigation does not require any permits.
